

## **Software License Term (Duration) and Software Maintenance Policy:**

GHOST 3D's Software and Software Licenses are offered, authorized, and supported exclusively under the terms and conditions of their corresponding Software License Agreement. Each original Software License must be rightfully acquired and authorized and is so granted exclusively for the number of installation(s)/copy(ies) corresponding to the number of user(s) as specified on the invoice, order form or by the according correspondence from GHOST 3D. When a Customer remits the fees for a full commercial Software License from GHOST 3D, this creates a Software License account in our records that is considered the "original Software License".

Each original Software License is granted and authorized for an indefinite non-perpetual period of time called a License Term ("License Term" means the period or duration of time during which an End-User is permitted to possess, use or access the Software as granted and specified by and in accordance with the terms and conditions of the License Agreement). The License Term is defined by and under the License Agreement and exclusively grants use of the last currently Authorized copy of the Software, whether it is the original installation or a subsequently Authorized maintenance or update copy as provided by GHOST 3D to replace the previously authorized Software copy under the same license. Typically the License Term may extend past any applicable Software Maintenance term, and therefore permits continued use of the Software exclusively with respect to the last Authorized and approved installation/copy only. Any Software License maintenance such as re-installations, re-authorization of installation(s)/copy(ies), patches or updates if available, License replacement, migrations (moving installations to a replacement computer), or other available technical assistance and support (collectively "**Software Maintenance**") for each Software License shall be subject to approval by GHOST 3D, and shall only be considered if available and requested under an active Software Maintenance term. Available **Software Maintenance** services, updates, and Software copies can only be supported and provided during either the period of an active **Complimentary Software Maintenance term** (typically **12 months** from the date of payment for the original Software license per Terms and Conditions of Sales or order form/invoice/product) or an active paid extended Software Maintenance Plan. Extended **Software Maintenance Plans** (a.k.a. Software License and Update Maintenance Plans) are available for most available GHOST 3D Software products and essentially extend the "no-charge" Complimentary Software Maintenance term (duration) for available maintenance service and updates. You can order a Software Maintenance Plan for use with a specific Software License at anytime. See below for terms and "Restrictions..." that apply.

## **Software Maintenance Policy and Software Maintenance Plan Terms and Conditions:**

The following Software Maintenance terms and conditions apply to any and all GHOST 3D Software products and any related Software bundles incorporating Software components (collectively referred to as "Software" in the following terms). The License Term (duration), maintenance, and any Software Maintenance service or Plan provided with or for the Software product(s) are governed under the corresponding Software's License Agreement **and subject to the following terms and conditions:**

1) **Original Software License:** Upon approved payment and Authorization for a Commercial License of the Software, the License Term shall commence from the date of first Authorization as provided by the License Agreement and shall extend indefinitely but not perpetually until such time as the License Agreement is Terminated. The License Term and Authorized use of the Software apply only to the originally authorized installation(s)/cop(ies) of the Software as designated by the number of user(s) specified on the invoice of the original Software License. A Software License is considered the "original Software License" when a Customer or End User remits the fees for a full commercial Software License from GHOST 3D. Any permissible Software re-installation, re-authorization, supported update(s) if available, License replacement, migration, or any other Software maintenance request or service may be granted at the sole discretion of GHOST 3D under an active Software Maintenance term such as the Complimentary Software Maintenance term (typically 12 months from date of license payment) or thereafter with the payment of an extended Software Maintenance Plan anytime during the License Term.

2) **Complimentary Software Maintenance** (includes currently available compatibility updates, migration and License re-authorization and replacements): A (no-charge) Complimentary Software Maintenance term is typically provided with payment for an original Software License. Unless otherwise stated on the Software order or invoice, this is a **12-month** "no-charge" Complimentary Software Maintenance term or period of time extending from the date of payment for the original Software license during which supported

Software activation, re-installation, re-authorization, available updates for compatibility use with a newer Platform or Host Application (Updates), License replacement, Migration (moving an installation to a replacement computer), and other available technical assistance and support maintenance may be considered under the original License at the request of the original End-User/Registrant and provided at the sole discretion of GHOST 3D without any incidental fees. All Software maintenance services are only offered for Software products when such service or Software updates are licensed, approved and made available by GHOST 3D to its general customer base. See below for "Restrictions..." that apply.

3) **Extended Software Maintenance Plans** (include currently available compatibility updates, migration and License re-authorization and replacements): Beyond the original Complimentary Software Maintenance term for "no-charge" Software Maintenance (typically 12 months from the date of payment for the original Software License) at any time an additional **Software Maintenance Plan** (or Software License and Update Maintenance Plan) may be ordered and provided for an applicable fee, establishing an extended term or period during which available and supported Software Maintenance, updates, migration, re-authorization, replacements and other available technical assistance and support maintenance may be considered at the request of the original End-User/Registrant and provided at the sole discretion of GHOST 3D without any incidental fees (see below for "Restrictions..." that apply). Current pricing, availability, and ordering instructions for the applicable Software Maintenance Plans corresponding to a particular Software product or custom plan can be requested and reviewed on the applicable GHOST 3D order form. Software Maintenance plans typically extend Software Maintenance opportunities for the duration of 12 months from the date of payment for the plan, or as designated on the order form or invoice for the plan. Software License Maintenance Plans include compatibility Updates when available, supported Migration, re-authorization service, and necessary License replacements at no additional cost or per-incident fee. This service may also qualify the End User for **discounts** on products and value-enhanced Upgrades but does not typically include no-charge value-enhanced Upgrades (value-enhanced Upgrades are upgrades to replace one product with another more valuable Software product or version priced differently as a different solution offering). Software Maintenance Plans or a paid License upgrade or extension may re-authorize or extend the License Term solely in accordance with the License Agreement, and may include free compatibility updates when available.

4) **Restrictions on Software Maintenance, Updates, Migration, and Re-authorization:** Regardless of whether offered or provided under the original Software License or under a Software License extension, renewal, update, or maintenance plan the following restrictions apply to all such Software maintenance: Due to the nature of the GHOST 3D integration Software products, GHOST 3D cannot and does not guarantee the availability of any Software updates, license extensions, migrations, upgrades or compatibility software(s) or service(s) for the Software. Please notice that any and all Software updates, upgrades, migrations, re-authorizations, License extensions, renewals, replacements, or other License maintenance opportunities and services are: (a) subject to availability, (b) may incur a lead time of 2-14 business days, (c) are offered at the sole discretion and approval of GHOST 3D, (d) are offered exclusively for the purpose of supporting the authorized use and continued access and use of 1 installation/copy (or number of copies/users specified on the original invoice) of the Software under the original Software License by the authorized End-User/Registrant per the terms and conditions of the applicable License Agreement. Absolutely no Software update, upgrade, re-authorization, License replacement, migration, or other Software or License maintenance may be construed as approval or used under any circumstances for the opportunity, means, or authorization to use, make, or enable additional installation(s)/copy(ies) of the Software in excess of the number specified on the original invoice, or in violation of any terms of the License Agreement, or a license or cause to use the authorized copy(ies) of the Software simultaneously by more than one user each.

**Notice and Termination Disclaimer:** *All GHOST 3D Software Licenses and Software License and Update Maintenance Plans are provided subject to the corresponding Software's License Agreement and GHOST 3D's current "Terms and Conditions of Sales" provided on the ghost3d.com website. Please notice that in any event that the License Agreement is terminated for any reason, or in any event whereby GHOST 3D, LLC dissolves as a company in its current form, as a result all Software Licenses, authorizations, Upgrades, Software License Update and Maintenance Plans, etc. shall become immediately void and terminated without remuneration or refund of any paid fees and without liability or damages of any kind due to any Registrant, End-User or Customer of such Software, or party to the Software's License Agreement, except in the sole case that an explicit written agreement between the Owner of Copyright and such Licensee (End-User of the Software) is executed establishing terms and rights between both parties that expressly contradict or supercede both these terms and the terms and conditions of the License Agreement. Customer and End-User agree to waive any and all right to refund, remuneration or compensation of any kind for any paid fees that are not subject to GHOST 3D's Refund Policy. All liability and damages of any kind resulting from the payment, receipt, installation, access, or use of any Software, Software License, Update, Upgrade, Software Maintenance Plan, replacement, or activation are expressly disclaimed.*
